

RESULTS WITH FREQUENCY INSTRUMENTS AFTER M.D.
DIAGNOSIS AND MEDICINES FAILED TO HELP PEOPLE....

These witnesses testified to their own experience that the Rife Frequency Instrument had cured them of various sicknesses...

Gertrude M. Couch: that is promptly relieved pain, headache and nervousness accompanying menstruation during onset of menopause, also relieved colitis and painful stiffness of back and neck, all of which M.D. doctors at Navy Hospital had not been able to help. (R.Tr., pp .1991-6).

Lloyd A. Edwards: that a tumor growth on his spine, which had grown to the size of an egg in 17 years, has practically disappeared after several treatments with the instrument; that fever blisters, which formerly took 1 to 2 weeks to heal, healed in 1 to 3 days after treatment with the instrument; that colds, which formerly lasted at least a week, cleared up in a couple of days or less when the Frequency Instrument was used. (Rep. Tr. pp.1555-61).

Margaret Ann Edwards: Painful sinus congestion and drainage cleared up in an hour after use of instrument; daughter's chronic sore throat, which formerly lasted 10 days to 2 weeks on each attack, even with medication, cleared up overnight when Frequency Instrument was used; that children's fever blisters, formerly lasting 1 week or more, cleared up within 12 hours after use of instrument: that painful breaking out of hands, which daughter had all her life attacks formerly lasting 2 to 3 months even with medication, cleared up in as little as 2 days after use of instrument; that daughter's very painful chronic ear-aches, which formerly required 3 months of doctor's treatments 3 or 4 times per week, promptly cleared up after use of Frequency Instrument. (Rep.Tr. pp. 1577-86)

Clinton L. Harwell: under treatment by M.D.'s without relief. August 1959 to April 1960, for recurring boils - lance and on shots, etc.; pain stopped within 30 minutes after the first treatment with Frequency Instrument, and boils no

1 which formerly required 3 months of doctor's treatments 3 or 4 times
2 per week, promptly cleared up after use of Frequency Instrument. (Rep.
3 Tr., pp 1577-86.).

4 Clinton L. Hartwell: under treatment by M. D. 's without relief, August
5 1959 to April 1960, for recurring boils - lanced and on shots, etc.;
6 pain stopped within 30 minutes after first treatment with Frequency
7 Instrument, and boils no longer recurred while he used instrument
8 frequently (though 2 boils recurred in a 2 week interruption of use of
9 Instrument - then cleared after use); that a growth he had had on his
10 chest as long as he could remember, dried up and fell off after 3
11 treatments with the Instrument; that sore throat was eliminated within
12 3 to 4 hours after treatment with the Instrument, 80 to 85% of the time.
13 (Rep. Tr., pp 1068-73, 1090-91, 1103-4.).

14 Marjorie Wayne: had injured left knee - very painful for 4 years;
15 treatment by M. D. doctors and massage gave no relief (She was a
16 Physio-Therapist); Frequency Instrument relief of Electron Therapy
17 stopped pain with one treatment, and after 6 treatments - no recurrence
18 of any pain or trouble during past 11 months; that she had a bladder
19 infection and irritation which was also cured by the Instrument. (Rep.
20 Tr., pp 1107-15.)

21 Ira Headley: had a lump (tumor) on side of throat which had grown to
22 the size of half a hen egg in 2-1/2 months; but after one treatment with
23 Frequency Instrument, began to shrink, --- has disappeared. (Rep.
24 Tr., pp. 1126-29.). (Ira's father had the same condition previously
25 and died of cancer of the throat.)

1 James F. Martini: had crushed finger; despite treatment by 2 M. D.
2 doctors December through February, end of finger continued to die
3 and slough off, with great pain; after 2 treatments with Frequency
4 Instrument, pain stopped within two days, and finger quickly healed.
5 (Rep. Tr., pp. 1033-34.)

6 Vina Montgomery: had severe pain in side periodically over the last
7 20 years, brought on every time she stooped over or stood in a certain
8 position; treatment by 5 M. D. doctors gave no cure, and pain recurred
9 at 2 week to 2 month intervals; after using Frequency Instrument 6 to
10 7 times, no pain thereafter in past 1 - 1/2 years: (Rep. Tr., pp 1138-94).

11 Rev. Edmund Martin Mueller: had pains in wrist and shoulder for 2
12 years; pain ceased after using Frequency Instrument 3 times; sinus
13 chronic infection for 50 years, had to use nose drops over 30 years to
14 keep head clear, but since using Frequency Instrument condition
15 relieved and cleared up in last year; had bleeding hemorrhoids and
16 prostate trouble since 1947, with very serious pain, but completely
17 cured after use of Frequency Instrument; had swollen gland under chin,
18 very painful for many years, but swelling and pain disappeared after
19 using Frequency Instrument; had small tumor growth in eyebrow many
20 years, painful even under light pressure, but after use of Frequency
21 Instrument, it opened, drained, and disappeared after a few weeks;
22 his colds were cured within 20 to 30 minutes and his "flu" cured within
23 24 hours by use of Frequency Instrument. These conditions were
24 treated by M. D. doctors without any improvement. (Rep. Tr., pp.
25 1930-41.). (Supt. of 200 bed Hospital in Mason City, Iowa...).

1 Lief B. Nerheim: had bursitis very bad in right shoulder, very painful;
2 received no relief from diathermy and osteopathic treatments; cleared
3 up after 2 or 3 treatments with Rife Frequency Instrument. (Rep. Tr.,
4 pp. 1150-52).

5 Rov Saltzman: had serious back injury from hand grenade explosion in
6 1942, left weak sacro-iliac joint which easily slipped out of place, often
7 causing severe pain and muscle spasms, sometimes almost paralyzed
8 below the waist; 3 M. D. doctors, a Chiropractor, and the Veteran's
9 Hospitals couldn't cure or relieve it; after 6 treatments with Frequency
10 Instrument 1 - 1/2 years ago has had no further trouble with back or
11 muscle spasms; his son had asthma so severe that M. D. had to be
12 called in the middle of the night about once per month, but after 6
13 treatments with the Frequency Instrument, his son has had no recurrence
14 of asthma in over a year; Frequency Instrument also cured ringworm
15 infection on the back of his large cat. (Rep. Tr., pp. 1217-21, 1232-36).

16 Ohmer W. Sensenbaugh: had contracted an itch in his ears in overseas
17 service, U. S. Navy, but no recurrence since Frequency Instrument
18 treatment over 2 years ago; had sinus infection of long duration, with
19 mild headaches all the time, - cleared up by use of Frequency Instrument,
20 which also promptly stops any recurrence; had very painful wrist that
21 was badly sprained; all pain stopped by Frequency Instrument and
22 condition cleared up; (also cleared up scarlet fever on his Navy Record -
23 ordered stricken by Court); his daughter's bad sinus infection not cleared
24 up by treatment by M. D. doctors, and attacks lasted a long time, but
25 Frequency Instrument has cleared it up in 3 days time, at least four

1 different times. (Rep. Tr. pp. 999-1002, 1013-16.).

2 Barbara Sensenbaugh: had varicose veins on legs, much enlarged and
3 very sore, but all soreness gone after 3 treatments with Frequency
4 Instrument, and swelling of veins largely gone after 3 treatments
5 (no operation needed); her new baby had a Staphylococcus infection
6 from Navy Hospital, white pustules on its skin - a girl friend's baby
7 had same infection; both were given medication; Barbara used the
8 Frequency Instrument which cleared up the infection right away while
9 her girl friend used the medication which left "pock marks" all over
10 the baby; Barbara's other child had much trouble with adenoids and
11 sinus infection and every cold would bring in a greenish discharge
12 from its nose for 3 to 4 weeks, but it stops within 3 days after using
13 Frequency Instrument. (Rep. Tr., pp 1016-25.).

14 Noel Tweed: had loss of hearing in left ear brought on by very annoying
15 "Ringing in Ear" since 1947; treatments by 4 M. D. doctors, including
16 a famous and M. D. ear specialist, gave no relief or hope of relief;
17 ringing completely and permanently stopped by treatment with Frequency
18 Instrument; he had "terrific attacks of hay fever" caused by allergy to
19 wood dust (he is Plating-Mill proprietor), treatment by M. D. 's gave
20 no relief, but the hay fever is now completely controlled by use of the
21 Frequency Instrument; he had a large wart on his thumb for many years
22 which was annoying but it disappeared after 3 treatments with the
23 Frequency Instrument. (Rep. Tr., pp. 970-75, 994-97.).

24 Lallas Bateson: had severe abdominal pains (abscess in colon) with pain
25 from the waist to thighs; cleared up after 4 treatments and yellow skin

1 color and brown spots on face cleared up with Frequency Instrument use.
2 Face discoloration had bothered her from 10 to 12 years - cleared up
3 in 3 months; had severe menstrual cramps for 25 years and excessive
4 flowing of blood - after treatment with Frequency Instrument had a normal
5 period with no excessive flow or cramps at all; had sore and itching on
6 side of left leg for two years but after treatment with Frequency
7 Instrument - no recurrence or trouble for past 2 years; had colds,
8 "flu" and sore throat often for years which last 4 days to a week but
9 Frequency Instrument clears up the conditions in 15 minutes; her
10 daughter had "Ringing of the Ears" which was cleared up in two
11 Frequency Instrument treatments; her daughter had colds and flu
12 which lasted 3 to 5 days but cleared up in hours with Frequency
13 Instrument use; her daughter had a fever of 104 degrees but after a
14 treatment with Frequency Instrument it started to subside and the
15 child was back to normal in 2 hours; Lallas had a toothache for several
16 years after dentist removed a nerve but pain was never relieved until
17 Frequency Instrument was used 4 times which cleared up the pain; her
18 sister had a growth between her toes which pained her to walk for many
19 years but after treatment with Frequency Instrument - condition was
20 relieved. (Rep. Tr., pp. 1943-53).

21 Dr. Leslie R. Drown, D. C.: Had an abscessed tooth with pain; after
22 Frequency Instrument treatment pain was gone in 15 minutes; had
23 intestinal flu with aching and pain for two days, after treatment with
24 Frequency Instrument, disease relieved in 20 minutes; his son had a
25 cold which cleared up within hours after Frequency Instrument use; a

1 Dr. Leslie Drown's evidence Continued:

2 woman patient had arthritis so bad she couldn't move her hand. After
3 15 minutes use of the Frequency Instrument she was able to move her
4 hand and move it without any pain, which she hadn't been able to do
5 for 6 months before that, and later on she had a heart attack where the
6 Frequency Instrument was used and the heart attack immediately
7 cleared up and she has had no treatments for it since and that was
8 another well person; another man patient came in with a bad backache
9 and with 3 treatments of the Frequency Instrument he was relieved of
10 pain and out healthy again. It was Dr. Drown's statement that pain is
11 eliminated by use of the Frequency Instrument immediately, that he
12 found it superior to the Ultra-Sonic Instrument Dr. P. Shea, A. M. A.
13 M. D. uses and that its cost was about 2/3 less from the \$650.00 of the
14 illegal Ultra-Sonic used by Shea (not approved by Public Health Dept.)
15 (Note: Ultra-Sonic is not bothered by Public Health Dept. because of
16 class-discrimination racket). Dr. Drown stated that his patients get
17 quicker results with the Frequency Instrument. (Rep. Tr. 1869 line
18 17 - 24 "... About the only way you can tell you get quicker results is a
19 patient doesn't come back and you see him 6 months or a year later and
20 say, 'How are you?' 'Oh, I am fine, I haven't had any treatments or
21 anything since I saw you last.' 'Well, why didn't you tell me?' -- He
22 just doesn't know, they forget when they get over their illness, they
23 forget it and it never lasts over three or four treatments..." End quote.
24 (Rep. Tr., pp 1866 -75.). Dr. Drown's practice is at 525 1/2 Laroda
25 in Eagle Rock off Glendale Blvd., Los Angeles, Calif.

1 Hilda Marsh: See Rep. Tr. page 1802 where Court refused to allow
2 Mrs. Marsh to say she had been cured of cancer over 6 years ago (at
3 time of testimony which was diagnosed by several M.D.'s and given
4 up by them but where cure was effected with Frequency Instrument;
5 that she has had cramps during menstruation and where Frequency
6 Instrument is used she has no cramps; that she had flu and colds which
7 lasted 3 to 5 days and longer but with Frequency Instrument treatment,
8 disease clears up overnight; that she had blacking out spells, nervous-
9 ness, and being constantly upset, where she would fall on the floor
10 which caused lumps to form on her head most of the time but after use
11 of Frequency Instrument - no recurrence has happened of these troubles;
12 that her daughter had mumps and fever which promptly relieved the
13 swelling and her child was able to go back to school after the swelling
14 went down; that Hilda had dizziness and pain in her female organs
15 which was eliminated by use of the Frequency Instrument. (Rep. Tr.,
16 pp. 1801 - 14.).

17 Benjamin Thomas Cullen (Rev.): that he treated a growth on his wife's
18 back (possibly skin cancer with infection) which dried up and went away
19 with the Frequency Instrument (and knows of hundreds of other cases
20 cured with the Rife Frequency Instruments) (Rep. Tr., pp. 1371-82).

21 Hazel F. Cullen: had a tumor growth on her back which fell off after
22 treatments with the Frequency Instrument. (Rep. Tr., pp. 1383-84)
23 Treatments lasted for about three months. (Evidence blocked by Court.)

24 Maxine Fuller: that a cold was treated with the Frequency Instrument
25 which cleared it up overnight. (Rep. Tr., pp. 1440.)

1 William E. McFadden: who came to testify about a cancer case that
2 was cleaned up with the frequency instrument and whose evidence was
3 blocked by the Court to "Cover Up" for the A. M. A. et al. A letter was
4 published in the Navy News Magazine; Vol. 23; No. 4, March 1960 at
5 page 11 - quote: "S. D. Researchers Make Inroads On Cancer Cure (The
6 Rife Virus Microscope Institute of San Diego, have had great success
7 in the treatment of cancer. The letter below is a testimonial of the
8 results of a recent success.) January 23, 1960, Box 306, Hope, Idaho.
9 To: Rife Virus Microscope Institute, 4246 Pepper Dr., San Diego 5,
10 California. Dear Sir: I want to tell you about my wife's case history.
11 Mrs. Helen McFadden (my wife) became ill in July of 1953. She was
12 60 years old then. She went to the doctor in Bonners Ferry, Idaho, who
13 found nothing wrong. She became worse and in October, 1953, I took her
14 to the Mason Clinic in Seattle, where Dr. Pearson, M. D., diagnosed
15 her case as acute pancreatitis and suggested surgery which was perform-
16 ed. The pancreas was found to be in poor condition with no malignancy.
17 She came home in November feeling some better but got worse in Dec.
18 In February, 1959, I took her back to Seattle and Dr. Pearson, M. D.
19 suggested another operation which was performed by Joel Baker, M. D.
20 who did the first one noted above. She was in the hospital for 4 weeks
21 and cancer was found to be in the pancreas and both doctors claimed
22 nothing could be done any further for my wife. Diabetes also developed
23 after the first operation. In September, 1959, we went again from
24 Bonners Ferry, Idaho, to Seattle, Wash. to Dr. Pearson, who gave
25 her an alcohol block to try and stop her pain. She had turned yellow in

1 color before we arrived there in Seattle. Dr. Pearson, M. D., said it
2 was just a matter of 30 to 90 days that she would die. Then we came
3 to San Diego and received treatments with the Frequency Instrument.
4 We arrived September 26, 1959 for her first treatments which have
5 continued to the present time of January 23, 1960. Last Thursday I
6 took her to Dr. Carlson, M. D., Ontario, Calif. Dr. Carlson stated
7 after diagnosing her case from laboratory tests that he could find no
8 tumor. Her cancer had gone away. When I brought her to San Diego,
9 she weighed 86 pounds and today she weighed 93 1/2 lbs., and is
10 steadily gaining every week. She is 5 feet 8 inches tall. The two
11 doctors in Seattle were considered to be outstanding medical men. I
12 was told by other people that the Rife method of treating cancer was a
13 quack method. But since I have personally observed the results on my
14 wife, I want to take this opportunity to express my sincere gratitude
15 for the elimination OF DIABETES AND CANCER from my wife's
16 painful condition. Sincerely yours, W. E. McFadden..." Note:
17 testimony blocked by Court at Rep. Tr., pp 1927-30.
18 Shirley Russell: had sinus and headaches so bad she could hardly
19 breathe, went to two Osteopaths who failed to help condition for years;
20 after 14 treatments all troubles cleared up with use of Frequency
21 Instrument. (Rep. Tr., pp 1202 - 04.).
22 Betty Maxine Nerheim: had fungus growth on her hands which was
23 cleaned up by Frequency Instrument and also hemorrhoids which
24 evidence was "COVERED UP" and blocked by the Court. (Rep. Tr.,
25 pp 1689-97.)

1 James Edward Hannibal: testified to being cured by Dr. Yale, M. D.
2 with Rife Frequency Instrument for blindness in his left eye, adhesions
3 from an operation that was 55 years old which were very painful over
4 12 years past, and was treated and cured by Dr. Yale for a bad
5 hemorrhage in the heart, so bad you could hear it hiss, and afterwards
6 regained his strength - one of thousands treated by Dr. Yale with the
7 Frequency Instruments. Note: his testimony was "COVERED UP"
8 and blocked by a Court of Law??? He never met any of the defendants
9 until a week before he testified - one of many who answered the ad in
10 the Los Angeles Papers (Rep. Tr. pp. 1821-20 quote: "Patients
11 relieved of any illness with electronic instruments by Doctors Couche,
12 Yale, Haimer, or Milbank Johnson over the past 25 years, please
13 write to John F. Crane... PRESERVE YOUR RIGHT TO RECEIVE
14 TREATMENTS WITH FREQUENCY INSTRUMENTS" offered by
15 defendants and the people also; entered at page 1821 as People's 41.)
16 (for Hannibal's remarks - see Rep. Tr., pp 1130-34.)

17
18 The foregoing cases are just a few that are known by RVMF
19 members. A few cases which were offered in evidence by letter
20 and tape recordings by doctors and which was foreclosed in the
21 interest of drug monopoly are set forth:

22 Dr. R. P. Stafford, M. D.: treated 52 people with Frequency Instruments
23 tabulated by clinical diagnosis:
24 1) Malignancies - 15 cases A) Carcinoma: 4 Breast, 2 Ovary, 2 Uterus,
25 1 Prostrate, 1 Lung, 1 Colon, 1 Stomach. B) Sarcoma: 1 Bone.

1 1 Melanoma. C) Neurological: 1 Astrocytoma of Brain.
2 II.) Infections - 22 Cases: A) Fungus of feet - 6, B) Bacteria: 4 Chest,
3 4 E. N. T., 4 Skin, 1 Bladder, C) Virus: 2 Chest, 1 G. I. Tract.
4 III. Inflammatory - 5 Cases: A) Arthritis - 1, Bursitis - 1, 1 Scalp,
5 2 Fibrositis. IV.) Miscellaneous - 4 Cases: A) Poison Ivy - 1,
6 1 Scleroderma, 1 Tinnitus, 1 Allergy (Thorazine), V) Prophylactic -
7 6 cases. Quoting now from his letter of January 20, 1961: "The 1st
8 animate object which we treated here in Dayton in 1957 was my 10 1/2
9 year old dog, Skipper. Skip had always been a very active dog until
10 he began to develop cataracts in 1956. Concurrently, he showed signs
11 of arthritis and became quite weak in his hind quarters. He could no
12 longer jump into the car and sit up on his haunches and beg for food
13 as had been his custom previously. When he ate, his hind quarters
14 showed a marked tremor. He frequently had purulent conjunctivitis. I
15 felt he would not live long - more than another year at the most. I
16 challenged John Marsh at that time to cure my dog with the Rife Machine.
17 John said he would - and he did! - A most remarkable improvement
18 occurred in Skipper even after the 1st Treatment. He was able to sit
19 up and beg. After several more treatments, Skipper was able to jump
20 into the car. The tremor in his hind quarters disappeared. The
21 purulent conjunctivitis cleared and old Skip acted like a young pup again
22 for the next 3 years..." "The 2nd animal experiment was carried out
23 in the spring of 1959 on Chloroleukemic Sprague-Dawley rats. These
24 experiments were conducted at the Miami Valley Hospital, Dayton, Ohio,
25 under the direction of Dr. Robert Zipf, M. D., Director of Research.

1. Dr. Zipf, assured me, that if I could extend the life span of any of the
2 cancer inoculated rats to 60 days, he would concede that we had favor-
3 ably influenced the course of their disease. The life span of 50% of the
4 cancer inoculated rats was extended one week while the remaining 50%
5 (approx.) of the cancer inoculated rats lived to 100 days and were
6 sacrificed at that time. This experiment aroused much interest and
7 respect for Dr. Rife's theories among the Research Lab Personnel. "

8 39 of the Cases I treated with the Rife Frequency Instrument are alive
9 and well today. He has on file many testimonials by his patients that
10 they are certain they were helped by the Rife Frequency Instruments.

11 Dr. Charles F. Tully, D.D.S.: used the Rife Frequency Instrument
12 where the following cases were cleared up to mention just a few:
13 (Where his evidence was blocked by Court to COVER UP for A.M.A.
14 monopoly Rep. Tr., pp. 1142-45.) A lady patient was treated for
15 Butterfly Lupis (Lupis Vulgaris) with red and purple marks all over
16 her face which was sent to me by Dr. R. J. McBride of La Mesa and
17 her own M.D. had treated her in Pasadena for 3 months without
18 results (a Skin Specialist). I treated her with the Frequency Instrument
19 for two weeks and at the end of that time it was entirely gone. Her M.D.
20 doctor was startled when he saw her walk into his office. He could not
21 believe that this had taken place. In my surgery I have used the
22 frequency instrument to replace anti-biotics which eliminates any
23 further infection. Another patient had Trench Mouth with his mouth
24 bleeding a lot with a stench. I treated him with the Frequency Instrum
25 and he did not bleed again; it cleared up completely in two weeks.

1 Another lady had a wound from a gall stone operation which was red and
2 itchy, and disagreeable and gave her quite a bit of trouble. I treated her
3 for 2 weeks with the Frequency Instrument 2 or 3 times a week and at
4 the end of that time she felt quite comfortable. I have treated a number
5 of cancer cases but it is hard to get anybody to believe that anyone can
6 do anything for cancer. This lady's ear was about 2/3rds gone and a
7 part of her face was eaten away with the cancer. It was treated with the
8 Frequency Instrument for 3 weeks and it dried up and healed over. A
9 number of pyorrhea (p. alveolaris) cases have all been cleaned up with
10 the Frequency Instruments thus eliminating the necessity of pulling
11 their teeth. "In our home we use the Frequency Instrument as a cure-
12 all for everything. I, myself, am susceptible to colds. When I find a
13 cold getting the best of me, I use the Frequency Instrument in the A. M.,
14 again at noon, and again in the evening. The next morning I find that the
15 cold is all gone." 3 cases have been cleared up of butterfly lupis.

16 Dr. Adolfo Torres Lara, M. D. Cancer Specialist, in Mexico:

17 Has cured many cancer cases with the Rife Frequency Instrument. His
18 story was published in "El Herald" Newspaper, Tiajuana, January 5,
19 1958, "He has the addresses of persons in good health and many of
20 them live in Tiajuana now. Many doctors know of these cases because
21 they saw the results when he was working in the Hospital of Miguel
22 Aleman. The doctors are just a bunch of quacks who will operate for
23 dollars..." See also, "The Actual Treatment of Cancer: A Formal
24 Deception" published by "El Herald" January 12, 1958, No. 4892,
25 page A-4. "Operations merely kill the patients and give no pain relief".

1 Dr. James B. Couche, M. D. of San Diego used Electron Therapy with
2 Rife's Frequency Instruments for 22 years curing hopeless cases where
3 his taped evidence was blocked as a COVER UP by the Court. A few
4 cases are listed which were cleared up by the Frequency Instruments:
5 14 cancer and T. B. cases at the Clinic in 1934 - one case "was that of
6 a man who staggered onto a table, just on the vast end of cancer; he
7 was a bag of bones. As he lay on the table, Dr. Rife and Dr. Johnson,
8 M. D. said, 'Just feel that man's stomach'. So I put my hand on the
9 cavity where his stomach was underneath and it was just a cavity almost
10 because he was so thin, his backbone and belly were just about touching
11 each other. And I put my hand on his stomach which was just one so
12 hard mass, just about what I could cover with my hand, somewhat like
13 the shape of a heart. It was absolutely SOLID ! And I thought to myself,
14 well nothing can be done for that. However they gave him a course of
15 treatments over 6 to 8 weeks and to my astonishment - he completely
16 recovered." Another patient, a girl of 19 had been operated on by
17 another doctor who had stripped out her hard glands in the stomach
18 area and closed her up. "In the course of some months afterward she had
19 developed other glands in the stomach and the other doctor had decided
20 to take those out too. So he opened her from the naval to the base of the
21 sternum and that was five months before I saw her. She was wrapped
22 in a large pad of absorbant cotton as the wound had not healed.
23 Tuberculosis wounds are very hard to heal and the cotton absorbed the
24 pus that was constantly flowing. He sent her to me. I placed her on
25 my operating table and upon exposing the abdomen found a lump about

1 the size of a hen's egg on the side of her abdomen which was terribly
2 sore. I treated her for 15 minutes on Wednesday and she came back the
3 following Monday morning on her toes. 'Well', she said. 'You can
4 punch me anywhere you like in my side'. 'What do you mean?' I said.
5 'All that soreness is gone and - Oh, I haven't had a period for over 3
6 months' she said, 'but 2 days after the treatment it came on and its the
7 first time without any pain.. ' She was 93 lbs. when she came to me
8 and 123 lbs. after 3 months treatments and that she never missed
9 another period and her other doctor told me that in a few years later
10 she weighed 145 lbs. and has never looked back. That was a startling
11 case because I practically instantly cured her tuberculosis and it was
12 a most outstanding condition.

13 Another case was a mouth condition , Cancrum Oris (gangrenous
14 stomatitis). It had eaten out his front lip 3/4's of an inch in extent so
15 that his teeth were visible clear through and his mouth was raw and,
16 stinky. Every doctor coming to the County Hospital had tried to help
17 but had failed. Everything had to be done for him. I treated him for
18 18 days and he was healed and well with the Frequency Instrument. My
19 brother came from England and he had had a sinus infection for 30 years.
20 I treated him for 5 weeks and the sinus healed and it cleared up. He had
21 3 operations which hadn't helped him one bit. The Frequency Instrument
22 was the answer. Another cancer case was cured with the Frequency
23 Instrument in San Diego - a Mrs. James Russell Jones who had been
24 operated on by 5 M. D. 's with resulting removal of one breast and with
25 180 cc drainage which was cured by the Frequency Instrument. I could

1 also cure Arthritis and Tuberculosis in other parts of the body. I had
2 4 cases in my records of persons loosing one kidney and having germs
3 in the other kidney which is eventually fatal. One woman was there in
4 the County Hospital at least 10 years before I cured her with the
5 Frequency Instrument. I had a 9 year old boy who had osteomyelitis
6 of the leg where he was treated at Mercy Hospital by doctors who
7 used to scrape the bone, every week. It was agonizing to the child
8 and the terror of that boy was awful. I treated him with his splints on
9 and in less than two weeks the wound was completely healed and he
10 took off his splints and threw them away and has never had any come-
11 back of his tuberculosis. I never treated a sinus that I didn't cure
12 with the Frequency Instruments. I was very good on growths also
13 had remarkable results with eyes, especially growths that become
14 very big. I could reduce tumors and also fibroids or neoplasms. I
15 also cured several Butterfly Lupis cases. I cured Dr. Haimmer, M. D.
16 of his sinus infection who was greatly impressed at Paradise Valley
17 Sanatorium and being a Superintendent he asked for a Frequency
18 Instrument. The Rife instrument was placed in the main room of the
19 Hospital where all the old chronic cases of colitis were treated and
20 all of them were miraculously cured that he had had there for a long
21 time. The doctors became incensed to loose their "meal tickets" and
22 Haimmer was forced to leave and again after he set up his own practice
23 in National City where he cured cancer cases and other cases, treating
24 about 40 a day in his clinic where Ben Cullen observed the results for
25 the Beam Ray Corp. My son was also cured of tuberculosis."

In January 1976 the New Age Journal published the inquiry: "What has become of the Rife Microscope?" which was written by Christopher Bird in Washington, D.C. along with the questions poised: Did Poyal Raymond Fafe find a bacterial agent associated with cancer? Did this inventor discover a means of electromagnetically curing cancer? and has one clique of scientists been able to suppress truth for half a century? These questions can be readily answered in the affirmative. From 1920 and on Rife was engaged in developing an electromagnetic instrument which he discovered would devitalize his viruses and bacteria and worms and fungi of a pathogenic nature by means of sympathetic and mortal oscillatory rates of potential electrical and electronic energy levels that were lethal to the micro-organisms observed under his virus microscopes, and harmless to human cells and animal cells.

Rife's work was thoroughly collaborated by Dr. Milbank Johnson, M.D. in three different clinics at Pasadena, California working with other medical doctors to verify the results. Dr. Johnson was the Medical Director of the Pacific Mutual Life Insurance Company in Los Angeles, California and one of the big powers in the A.M.A. and when ready to announce his findings, he was poisoned and died in a hospital shortly thereafter. His clinics were in 1935, 1936 and 1938.

In 1934, Milbank Johnson, M.D. set up a clinic using the Rife electromagnetic ray methods at the Ellen Scripps Ranch in San Diego where 15 hopeless cancer patients were pronounced clinically cured in 60 days treatment time. Other medical doctors participating in the clinic were Dr. James B. Couche, M.D. and Dr. Authur I. Yale, M.D. both of San Diego who later on used Rife's ray tube instruments for 22 years with great results. Both men being prominent surgeons of World War I.

Rife built five virus microscopes from 1920, one in 1929, one in 1933 called the universal, one in 1934 and one in 1937 which was finally finished in 1952 at the research facility of Allied Industries set up by John F. Crane in which six ray tube instruments were designed and built with the aid of Verna Thompson who was an electrician expert with the San Diego Police Department.

Not content with seeing and isolating viruses and observing polarity effects on the reproduction of the micro-organisms in which all positive or all negatively attracted micro-organisms readily died and would not reproduce, Rife also found that neutral polarity micro-organisms would not reproduce. Thus by using positive polarity on the right side of the body and negative polarity on the left side of the body, polarity forces could be induced to eliminate the reproduction cycles of the micro-organisms and thus control the diseases to a standstill.

This has resulted in a little known realization that man is capable of great progress and noble ideas, but that, human nature being what it is, their embodiment in practical achievements is doomed to failure by those who suppress progress in which free breakthroughs rudely collide with monopoly controls of life; "We build statutes of snow and weep to see them melt". An unshakable faith and an iron will has been required to prove that old facts are true even after monopoly controlled thoughts failed to heed the new facts or the old facts and keeps assailing them.
